Please be reminded on the inquiry/clarification raised during the Pre-Bid Conference held on May 4, 2026 which was also addressed and clarified during the meeting, to wit:

1. Winning Bidder's Additional Requirements to be submitted after receiving the Contract and Notice to Proceed

The End-user and Technical Working Group (TWG) clarified that the submission of the following documents by the winning bidder **shall be within Thirty (30) Calendar Days after receiving the Contract and Notice to Proceed:**

- a. Boat plans, drawing and design to be prepared and signed by a duly licensed Naval Architect and approved MARINA and Local Classification Society (for new construction only)
 - General Arrangement Plan
 - Lines Plan
 - Inboard Profile Plan
 - Engine installation details
 - Electrical installation details
 - Construction plan
 - Scantling
 - Capacity plan
 - Specifications and arrangement of Main Propulsion System
 - Shafting Arrangements
 - Rudder Plan
 - and other related plans and drawing required by MARINA

The design shall be subject to inputs by BFAR prior to its submission to MARINA for final approval. Notwithstanding such review, full responsibility and liability for the adequacy, accuracy, and compliance of the design shall remain with the supplier/boatbuilder. The thirty (30) calendar days stated above exclude the BFAR review period.

All boat plans, drawings, and designs submitted by the winning bidder, including all associated intellectual property rights, shall become the property of DA-BFAR.

Amendments/inclusions/clarifications made herein shall be considered as an integral part of the Bidding Documents.



The deadline for submission of proposals is on **May 21, 2026, at 9:30AM** at the BFAR-FishCoRe Procurement/SBAC Secretariat at the 2nd Floor, National Food Authority, Visayas Ave. Diliman, Quezon City. **The Opening of Bids is scheduled on the same date at 10:00AM at the same venue.**

Late quotations/proposals shall not be accepted.
